KMK Law Hosts Fourth Annual Diversity Case Competition





On January 14 & 15, 2022, KMK Law, in partnership with the University of Cincinnati College of Law's Center for Professional Development, hosted the fourth annual Diversity Case Competition for first year minority law students – the nation's first and only competition of its kind. This year the competition, which was held virtually, was comprised of 11 teams from 6 area law schools: Case Western Reserve University Law School, Salmon P. Chase College of Law, Northern Kentucky University, University of Cincinnati College of Law, University of Kentucky J. David Rosenberg College of Law, University of Louisville Louis D. Brandies School of Law, and The Ohio State University Moritz College of Law.

The competition simulates the real-world associate experience, complete with the evaluation and feedback processes used in most law firms. Using the case model, students competed for cash prizes by displaying their analytical, problem solving, and communication skills – all skills that are key to success in the legal industry. The competition also exposed students to practicing attorneys and Fortune 500 corporate counsel, who served as coaches and judges.

"When we started this competition, we not only wanted to create a meaningful experience for the law students, but also wanted to make real, impactful advancements in diversity and inclusion at KMK Law and in the legal industry as a whole in Cincinnati," said Bethany P. Recht, KMK Partner and Co-Chair of the Diversity & Inclusion Committee. "In just the first four years of the competition, KMK Law has hired several minority law student competitors for the positions of summer associate, law clerk and associate, and former competitors are also receiving law student job opportunities from our clients who serve as judges for the competition."



This year's program opened with guest speaker Jaia Thomas, a Walnut Hills alum who now works as a sports and entertainment attorney. Thomas is the founder of Diverse Representation, an organization focused on increasing the exposure and number of African-American agents, attorneys, managers, and publicists who work in the sports and entertainment industry.

The program also included Dean Verna Williams from the University of Cincinnati College of Law who spoke about the success of the annual Case Competition and the significance of the competition being held on Martin Luther King, Jr. weekend. ≪

KMK Law Hosts Antisemitism Training Program

On November 8, 2021, KMK Law hosted a special luncheon training opportunity for all KMK attorneys and staff presented by the Nancy and David Wolf Holocaust and Humanity Center and the Jewish Community Relations Council of Cincinnati, which facilitated important, relevant lessons about antisemitism today and how individuals can take a stand against it.

Hate at Home: Antisemitism and Why it Matters Today explored how antisemitism has changed over time. From the Holocaust in Europe to contemporary antisemitism and hate at home in Ohio, this program inspired attendees to combat antisemitism and other forms of extremism in their own communities. Recently released crime data shows hate crimes at a 16-year high, according to the FBI. The most recent study



on antisemitism by the Anti-Defamation League (ADL) shows that the number of incidents in 2019 were the highest since they began reporting in 1979. Ohio is not immune to this current trend. Antisemitism on both sides of the ideological spectrum, exhibited in new and sometimes deadly ways, demands that communities find ways to combat it. One of the best approaches to combating it is to build allies and an understanding that hate against one group of people impacts us all.

In follow up to the antisemitism training program, on January 27, 2022, KMK Law recognized International Holocaust Remembrance Day—the anniversary of the liberation of Auschwitz-Birkenau—on which the world remembers the six million Jewish victims of the Holocaust. On the eve of that Day of Remembrance, KMK attorneys and staff were invited to virtually attend the Holocaust Speaker Series presented by the Nancy & David Wolf Holocaust & Humanity Center, in partnership with the Harriet and Kenneth Kupferberg Holocaust Center and Maltz Museum of Jewish Heritage, featuring Eva Schloss the neighbor and posthumous stepsister of Anne Frank. **《**
