KMK Law Hosts Fifth Annual Diversity Case Competition

On January 13 & 14, 2023, KMK Law, in partnership with the University of Cincinnati College of Law's Center for Professional Development, hosted the fifth annual Diversity Case Competition for first year minority law students. This year the competition was comprised of 17 teams from 6 law schools in Ohio and Kentucky: Northern Kentucky University Salmon P. Chase College of Law, University of Akron School of Law, University of Cincinnati College of Law, University of Kentucky J. David Rosenberg College of Law, University of Louisville Louis D. Brandeis School of Law, and University of Toledo College of Law.

"We were thrilled to host this year's competition back in person in our downtown Cincinnati office," said Bethany P. Recht, KMK Partner and Co-Chair of the Diversity & Inclusion Committee. "We delivered a premier learning experience for racially diverse law students through a challenging case competition and provided networking opportunities with legal professionals from around the Greater Cincinnati area. This program will continue to be a part of KMK's ongoing commitment to inclusion and diversity at KMK Law."



The competition simulates the real-world associate experience, complete with the assignment, evaluation and feedback processes used in most law firms. Using the case competition model, students competed for cash prizes by displaying their analytical, problem solving, and communication skills - all skills that are keys to success in the legal industry. The competition also exposed students to practicing attorneys and Fortune 500 corporate counsel, who served as assigning partners, coaches and judges.

"KMK Law is excited to host the nation's first and only diversity case competition. We hope this program will further develop each student's passion for the legal industry as they continue their law school education."
